Dear partner in ministry,

We have had much to praise God for in 2007. His faithfulness to GCM and its missionaries continues to encourage and sustain us. He is truly the Great Provider! It is only through His power that GCM was able to serve churches and mobilize missionaries for the Great Commission.

Our focus in 2007 was on recruiting staff and expanding our partnerships with churches and church networks across the United States and Europe. We held some of our largest New Staff Training classes in recent years. We also redesigned the GCM website and launched MyGCM.org, a website designed to serve donors. This has been a tremendous success, with over half our new recurring donations coming through this site since its launch.

Campus Ministry

In 2007, over 160 GCM missionaries were employed for church-based campus ministry. There was a renewed focus on planting churches on strategic U.S. campuses. Teams were formed and prepared for church plants at Ohio State, Kent State, and Florida State Universities. New Life Christian Fellowship at Virginia Tech started "NLCF Downtown" to serve young professionals and families in Blacksburg. And six men were ordained as pastors or commissioned as deacons for campus church ministry in 2007.

The Leadership Training (LT) program had another successful summer of discipling and training college students. More than 200 students attended LT in one of three locations: Wilmington, NC, Virginia Beach, VA, and Estes Park, CO. IGNITE, the student conference of GCM Churches, was held in December with over 400 in attendance.

Missional / Community Ministry

In 2007, GCM employed nearly 50 missionaries to work in missional churches in the U.S., supplying local churches with staff they could not otherwise support. For these urban and community churches and church plants, 2007

was a year of growth. GCM missionaries helped plant Kairos West in Los Angeles, Vista Community Church in Dublin, OH, and Rio Community Church in El Paso, TX. They also prepared for 2008 church plants in Richmond, VA, and Des Moines, IA.

This year we developed a growing relationship with the Acts 29 church planting network. We were also able to work with a number of independent churches throughout the U.S. Through these partnerships, we have been able to serve missional church plants in Seattle, St. Petersburg, Pittsburgh and New York.

International Ministry

Many of the churches where our international missionaries are serving made transformational steps in 2007. Missionaries serving with Great Commission Europe reaffirmed their desire to be "catalytic" and come alongside nationals to help them start new works, rather than leading these efforts themselves. At the GCM Missionary Retreat in Bled, Slovenia, pastors expressed their desire to see churches become indigenous, self-governing, self-supporting and self-propagating.

A highlight from 2007 was the growth of simple churches in Ukraine, which missionaries like Timmy Powers and Steve Nelson have helped to plant and shepherd. Today, there are GCE churches in Italy, Poland, two in the Netherlands, four in Ukraine, and four in Germany. And a church will be planted this coming year in Pamplona, Spain.

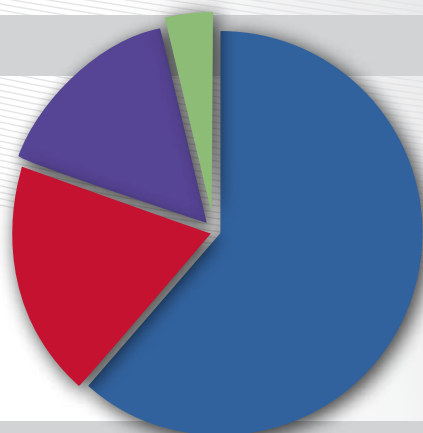

2007 Financials

Dear friends of GCM,

Thank you for your faithful partnership with Great Commission Ministries. Through your generous giving, God graciously supplies the needed resources for this ministry. We never take this blessing for granted. We take our responsibility to be stewards of these resources very seriously. As such, we want to inform you annually about the finances of the ministry you support.

GCM maintains internal financial controls that assure good stewardship and prudent business practices. The 2007 financial records were audited by the independent certified public accounting firm of Capin Crouse LLP. (A copy of their auditor's report is available upon request from GCM.) In addition, an Audit Review Committee examines and approves the annual audit. This committee meets twice a year to insure that the highest standards of financial integrity are consistently maintained and that GCM adheres to the requirements of the Evangelical Council for Financial Accountability (ECFA).

GCM management is responsible for the financial information presented in this annual report. The surplus from operations of \$144,789 as shown in the 2007 Excess of Support & Revenue Over Expenses Section represents ministry fund surpluses that were raised this past year, but will be eventually spent in 2008.

The ministry of GCM continues to grow and expand because of our loyal ministry partners. As you can see, the majority of our ministry support comes from the contributions of individuals like you. It's your generosity that allows us to advance the kingdom of God. Thank you for being a vital part of spreading the gospel and helping to fulfill the Great Commission of our Lord Jesus Christ.

As a 501c3 organization, GCM exists to train, employ and serve missionaries as they raise a team of supporters for their GCM ministry. Our services to missionaries include an eight-day intensive training in support-based ministry, personal coaching and follow-up conferences, salary and benefits, reimbursements, technical support, donor services, and grants for fundraising.

As a non-denominational evangelical organization, GCM values the autonomy of the local church and entrusts the spiritual oversight of its missionaries to local church leaders. This allows GCM to focus on what we do best—making ministry a sustainable profession.
